



## Agreement & Terms

This agreement is between South Coast Together (address and other contact info), herein referred to as \_\_\_\_\_), and \_\_\_\_\_ (address and other contact info), herein referred to as the Licensee. It covers the display, printing and use of all content of the Help That Helps and Guide. This Curriculum is a product of South Coast Together which grants this access and use.

## Grant of License

South Coast Together grants to the designated Authorized Licensee (hereinafter "the Licensee"), and the Licensee hereby accepts, a non-exclusive, revocable, non-transferable License to access and use the Licensed Property subject to the terms and conditions set forth herein.

## Licensed Property

The Licensed Property is the *The Help That Helps Curriculum* (a digital product), created by partners including: the digital Curriculum files in a PowerPoint format and to the digital Guide files in a printer-ready format.

## Authorized Users and Authorized Access

The Licensee may use the digital curriculum in free presentations and make PDF copies of the curriculum (powerpoint slides and speaker notes) available at their expense if they so choose. The Licensee shall make reasonable efforts to provide attendees of these trainings with appropriate notice of the terms and conditions under which access to the Licensed Property is granted under this Agreement, including any limitations on access or use of the Licensed Property as set forth in this Agreement.

## Authorized Uses

The Licensed Property may only be used for purposes of education.

Licensees may download and present the Help That Helps Curriculum and they may make paper copies of the curriculum and the Help That Helps Guide itself.

## **A.Unauthorized Uses**

Licensees are authorized to allow only employees and volunteers of their organization to use the licensed property and therefore need to acknowledge that content will not be shared outside of the Licensees' program. This agreement does not permit anyone other than Authorized Users to use the Licensed Property nor permit Authorized Users to use the Licensed Property for any uses other than Authorized Uses.

The Licensee shall not modify, translate, or create a derivative work of the Licensed Property.

The Licensee shall not modify, remove, or obscure any copyright notices or other notices included in the Licensed Property.

The Licensee shall not use the Licensed Property for commercial purposes, including but not limited to sale of the Licensed Property or bulk reproduction or distribution of the Licensed Property, or any portion thereof, in any form.

*Any unauthorized use of any of the license's property constitutes copyright infringement and subjects unauthorized users to applicable to possible civil and other penalties.*

## **Ownership and Protection of the Licensed Property and Reservation of Rights**

South Coast Together (SCT) is the owner of the copyright and content of the Licensed Property. Except as expressly set forth herein, all rights of whatever nature in and to the Licensed Property are reserved by SCT, including, without limitation, the right to authorize others to access and use the Licensed Property.

The Licensee shall make reasonable efforts to prevent Unauthorized Uses of the Licensed Property. In the event the Licensee becomes aware of any infringement by third parties of any rights licensed herein, or any other unauthorized uses of the Licensed Property, the Licensee shall promptly notify SCT in writing of such infringement or unauthorized use, and shall do such acts and assist in supplying such information as is reasonably necessary or desired by SCT in relation thereto.

SCT shall take only those steps which, in its sole discretion, are necessary to enforce its rights, including the engagement of legal counsel of its own choosing. Nothing herein shall obligate SCT to take any action against any allegedly infringing party or unauthorized users. Upon SCT's request, the Licensee will cooperate fully, at SCT's expense, in confirming, perfecting, preserving and enforcing SCT's rights in the Licensed Property. During the Term of this License, at SCT's request, the Licensee shall indicate in its use of the Licensed Property that such Licensed Property is owned by SCT and that SCT has copyright protection therein. The Licensee shall acquire no ownership rights to the Licensed Property by virtue of this License or otherwise. The Licensee shall not, during the Term of this License or at any other time thereafter, directly or indirectly, contest or aid others in contesting SCT's ownership of the Licensed Property. The Licensee shall not, during the Term of this License or at any other time thereafter, do anything which impairs SCT's ownership of, or the validity or reputation of, the Licensed Property.

## **Rates and Fees**

The Curriculum use and Guide printing license is provided at an annual cost of \$1,200.00. The Fee must be paid before access to the Licensed Property will be activated (unless otherwise agreed to in writing by SCT).

Renewal for the License may be purchased by the Licensee each year. A renewal License Fee will be invoiced by SCT in advance of each agreement anniversary date of the Licensee's License. The renewal License Fee shall be at the rate in effect on the invoice date

## **Warranties, Disclaimer, and Limitations of Liability**

SCT warrants that it is the owner of the Licensed Property or that it has secured permission to use any copyrighted material in the Licensed Property; and that it is entitled to grant the rights to which this License applies. SCT makes no other representations or warranties of any kind, express or implied.

To the fullest extent possible by law, SCT disclaims all warranties, express or implied, including but not limited to any implied warranty of non-infringement, merchantability and/or fitness for a particular purpose, or that materials and information licensed hereunder will be error free, or that defects will be corrected, or that the product is free of viruses or other harmful components, nor shall SCT be liable for damages of any kind, including, direct, indirect, incidental, special, consequential or exemplary damages, or other claims, arising out of the use or the inability to use the Licensed Property or the material and information contained therein or from errors contained in the materials.

Licensee's expressly acknowledge and agree that the use of the licensed property is at the sole risk and entire risk of the licensee and authorized users.

## **Term and Termination of License**

This License shall be effective upon SCT's receipt of the Licensee's payment of the License Fee.

Authorized License Application/Agreement, signed in acknowledgement of acceptance of the terms and conditions stated herein and SCT's receipt of the Authorized License Fee, shall remain in effect until terminated pursuant to the following provisions (the "Term"): one calendar year

SCT may terminate a license when it deems that the licensed materials have not been used as agreed.

The Licensee may terminate its License, thereby declining the privilege of accessing and using the Licensed Property, at any time by giving written notice to SCT, provided that in the case of such termination, the Licensee shall not be entitled to any refund of License Fees already paid. Upon the termination of this License, at the end of the Term or otherwise, SCT will deactivate the Licensee's access to the Licensed Property and the Licensee will discontinue use of the Property.

The Licensee assumes sole responsibility for all use of the Licensed Property and agrees to indemnify and hold the Licensor harmless from any claim, liability, or loss arising from their unauthorized use. Licensee knowingly allows use of the licensed materials by employees or volunteers who misrepresent scientific findings or make substantial errors presenting information contained in Curriculum or Guide, or who, after being notified of above problems, fail to either coach, re-educate or otherwise assure accurate

presentation, or provide written notice to the individual that their use of the materials is revoked along with taking action to assure that this decision is reasonably enforced.

## **Governing Law and Jurisdiction**

This License shall be governed and interpreted in accordance with the laws of the United States and the state of Oregon.

## **Entire Agreement**

This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter hereof. No amendments to or modifications of this Agreement will be binding unless in writing and signed by the parties.
